Rafael Dal-Ré is a Doctor of Medicine from the Universiad Complutense in Madrid (UCM) and he holds a Masters degree in Public health from the Universidad Autónoma in Barcelona (UAB). During his career he has served as medical director of various pharmaceutical companies. He has been involved in clinical research for over 20 years, and he has more than 140 papers published in international and national journals. Several of these papers relate to various aspects of bioethics in research involving human subjects and the Declaration of Helsinki.

The Declaration of Helsinki, developed by the World Medical Association (WMA), establishes ethical principles for medical research. It is now fifty years since the document was written and the WMA is currently completing an update to the original version. In this lecture Rafael Dal-Re will review the contents of the Declaration, he will talk about their origin, the revisions that have been made and some of the most controversial aspects it contains.
